We are a family of ordained ministers who have been granted legal right to marry people in the State of Oklahoma. Our founder, Rev. Joane Fogel, has been officiating at weddings since 2000. Collecting vows of many religions, including most Christian religions (modern and classic), Jewish, Buddhist, Tao, New Age, and Secular (no religion), she has specialized in meaningful, romantic and personal, one-of-a-kind vows.

Rev. Joane lives in Norman, OK, with her husband of 49 years, Dr. Norman Fogel, who is also an experienced, ordained, lay minister registered with the state of Oklahoma.

Recently, our family business of ordained ministers has expanded to include their daughter, Dr. Dara Fogel, and son-in-law Richard Auer.

FEES

Since we come to you, we base our prices in part on the distance we must travel to your chosen location. We consider downtown Norman our center, (Main Street and University) and we use Google Maps to calculate distance, to help avoid disputes.

Payment is made with cash in an envelope at the wedding.

- Our base charge for doing a wedding **within 50 miles of Norman is \$150.**
- Places greater than 50 miles out from center, we will have to talk about it.
- There is a **\$50 non-refundable deposit** which is used as a retainer for services rendered prior to the ceremony (writing and arranging the vows, printing, etc.)
- We also charge an additional \$50 for onsite rehearsals.

An initial face-to-face meeting to discuss your wedding is included in our service fee. We usually meet at **Panera** on Main Street in Norman, just east of I-35, on Mondays through Wednesdays after 6 p.m. Please call to arrange an appointment.

Contract & Cancellation Policy

Clients are responsible for all fees for services provided by Get Married Your WayTM and its representatives. If for any reason the wedding is cancelled, clients forfeit their deposit. If wedding is cancelled without at least 24 hours notice, clients are responsible for the full amount.
